I wish to reassure our national membership that last Saturday's change to the political landscape of our country will not stifle the resolve of your national executive to put forward our issues of concern, to the new Labor Government.

Our submission to the former Prime Minister about the DFRB/DFRDB anomalies was not acknowledged, but I did receive a courteous email response from Alan Griffin MP then Shadow Minister for Veterans' Affairs. This will be pursued when the portfolios of Defense and Veterans' Affairs are allocated by the new Prime Minister later this week.

The issue of the Pingat Jasa Malaysia (PJM) was before ex- Minister for Veterans' Affairs Bruce Billson since October 2006 without response, so this matter will be included in a submission to Prime Minister Rudd before years end.

This submission to the Prime Minister will present a case against the ongoing discrimination toward RAN personnel who served in the FESR. I believe we of RAN service in the FESR from 1955- 1971 or any post WWII service for that matter, have sufficient examples on which to build such a case.

We have paid dearly for the "Silent Service" syndrome and discrimination for us started when the defense mind-set elected to treat our service differently from our brothers in arms in the respective theatres of conflict.

The historic Mohr Review proved how arcane the criteria for recognition of RAN service are, but it continues today. Highly discriminatory procedures with the award of the ASM with clasp FESR preceded the Mohr Review, as did the battle for the award of the VLMS.

Recognition of our service is a continual battle with the bureaucracy. Public acknowledgment of our theatres of operation on national war memorials is a work in progress, albeit some 50 years after our service.

Outrageous criteria set by our government for the award of the PJM to RAN personnel who served in the FESR is another example of the government determination not to recognize our service- we understand The Malaysians wish to do so.

The debacle of our lack of representation at the 50th Anniversary Celebrations of Merdeka Day in Kuala Lumpur in August of this year beggars belief. The Malaysians even questioned our absence. Again, we were refused a mission to the event for quite shallow reasons.

Our marketing initiative to stimulate membership of ex-service organizations like ours was rejected by former Minister Bruce Billson on the basis among other reasons that it would not work. The Queensland RSL has used the concept with striking results.

The concept is included in a Victorian Veterans Council submission to their state government and we await the outcome. I shall re-submit the concept to the new Minister for Veterans' Affairs in December for appraisal.

I have a copy of the 28-page election 2007 policy document "Labor's Plan for Veterans' Affairs" which I shall work through in collaboration with your National Executive and National Council. We will pursue the content in the interests of our membership.

As you know our charter is apolitical, so you may all rest safe with the knowledge that my
